Gentlemen:

We refer to your letter dated February 5, 2018 requesting for clarification and/or confirmation of the news article entitled "PLDT unveils P180-B spending plan" posted in Inquirer.net on February 5, 2018. The article reported in part that:

"Industry giant PLDT Inc. is flexing its massive financial muscle, revealing for the first time a multi-year capital spending plan as the Duterte administration hopes to select a new telco challenger in the next few months.

PLDT, in a statement over the weekend, announced an unprecedented three-year spending budget of P180 billion from 2018 to 2020—or P60 billion per year—to help double fixed-line and mobile internet capacity in the next year and a half.

...."

In the PLDT Press Release entitled: "PLDT's 5-year P260-B Capex Program Enters 3rd Year" a copy of which we filed with the PSE on 5 February 2018, we indicated that total capex for 2016-20 is estimated at P260 billion. Capex for 2016 amounted to P42.8 billion. The capex for 2017 is still being finalized, but estimated at between P39-40 billion. Given this, the capex for 2018-2020 will range from P177-178 billion.
