11. Item 9 (Other Events)

We disclose that Philippine Long Distance Telephone Co. ("PLDT") issued today, November 22, 2012, PHP 6.20 billion fixed rate corporate notes to a group of primary institutional lenders. The 7-year and 10-year notes were fixed at a yield of 5.50 percent, and 5.9058 percent, respectively.

BPI Capital Corporation and First Metro Investment Corporation acted as the Joint Issue Managers for this transaction. Proceeds from the said facility will be used to refinance PLDT's existing debts in line with the company's liability management initiatives to reduce financing costs and rationalize its debt maturities.

Pursuant to the requirements of the Securities Regulation Code, PLDT has duly caused this Report to be signed on its behalf by the undersigned hereunto duly authorized.
